## Careel Bay dog off-leash area community feedback and Council response summary – August 2018

Council received 70 submissions in response to the public exhibition of the proposed enhancements to this dog off-leash area.

The feedback we received related broadly to the Careel Bay project and also to dog walking across the Northern Beaches.

The off-leash area prevents access for other activities.	Council supports the retention and enhancement of this dog off-leash area. There are a limited number of off-leash areas on the Northern Beaches with a growing demand for more. There is a sports field adjacent to this off-leash area available for casual use when not in formalised sporting use. No change to the plan.
Selective planting to screen fencing.	Where practicable and as budgets allow, Council will consider selective planting to enhance the aesthetics of the park.
Etiquette signage.	Signage in the dog off-leash area will be reviewed, upgraded and replaced as required in 2018/19. Etiquette signage will be installed.
