
1. Summary¹

This report outlines the community and stakeholder engagement conducted between 29 January and 28 February 2021 as part of the proposal to name the Fern Creek Reserves in Warriewood, Lynne Czinner Park.

The majority of comments received were in support of the proposal as a fitting tribute to Lynne Czinner.

The main reasons described in the feedback against the proposed naming included a preference for an indigenous name and retaining the name Fern Creek. Some specified that the reserves should not be named after an individual.



1.2. Who responded²



2. Background

Lynne Czinner was a Councillor and later Mayor of the former Pittwater Council. She was a passionate advocate for the protection of the natural environment and campaigned to protect the Warriewood wetlands and escarpment.

After her passing, Council resolved to find an "appropriate location for a memorial in [Lynne's] honour". In consultation with Ms Czinner's family, it was decided that naming the reserves at Fern Creek Warriewood after Lynne would be a fitting recognition of her contributions.

3. Engagement objectives

- Provide accessible information so community and stakeholders can participate in a meaningful way (inform).
- Identify community and stakeholder concerns, local knowledge and values (consult).
- Build community and stakeholder awareness of the project and the opportunity to provide comments (consult).

4. Engagement approach

Community and stakeholder engagement for the Naming Proposal – Lynne Czinner Park project was conducted over a four-week period, from 29 January and 28 February 2021.

The engagement was planned, implemented and reported in accordance with Council's Community Engagement Matrix (2017). The engagement approach is outlined in the Naming Proposal – Lynne Czinner Park Community and Stakeholder Engagement Plan (November 2020).

A project page was established on our have your say platform with information provided in an accessible and easy to read format.

The project was primarily promoted through our regular email newsletter (EDM) channels.

Feedback was captured through an online comment form embedded onto the have your say project page. The form included a question that directly asked respondents for their level of support on the proposal.

An open-field comments box provided community members a space to explain or elaborate on their support, not support or neutral sentiment as well as any other feedback they wished to contribute.

Email and written comments were also invited.

5. Findings³

During the feedback period, 62 submissions were received. Of these, 68 percent supported the proposal, indicating that naming the reserves in Lynne Czinner's honour was a fitting tribute to a person who contributed a lot of her time to protecting the local environment.

Twenty four (24) percent of the comments received did not support the proposal for various reasons. Some indicated that they preferred to maintain the current name - Fern Creek or to choose an Aboriginal name to acknowledge the local indigenous heritage. Other commenters suggested a simple plaque with a description of Lynne's community contribution would be a suitable alternative.

A few respondents indicated that places in the northern beaches should not be named after single individual as there are many worthy recipients and the selection process to identify the worthiest is subjective.

Prior to the amalgamation of the three councils the Narrabeen Lagoon and it's catchment was overseen by shared Council's Committee with the long winded acronym and name, (NL JE & FMC) Narrabeen Lagoon Joint Estuary & Floodplain Management Committee. Lynne was a long time serving, and passionate member of that committee. During that period I was a member, in the capacity of a "Citizen Representative & an Anglers Action Group Inc representative". Lynne was not a fisherman, but was very interested in maintaining the Lagoon's marine habitat, including maintenance of Evolved Water Levels. I think that this will be a great tribute to Lynne.		
	I am very happy with the name Czinner Park but not Lynne Czinner Park. It seems that only in the last 50 years that first names have added to names of places. Adding the first name is cumbersome. By all means erect a plaque that gives Lynne due recognition but keep it simple. First names have been known to be dropped off other place names. Not that the first name I will use here is correct but I am glad our early citizens did not choose to give us Fred Hyde Park in		
10	Sydney's CBD. I don't believe any park/reserve/whatever should be named after just one individual. I think Lynne did a great job and perhaps a plaque somewhere to commemorate that could be done but there are too many great people on the Northern Beaches who could, and should, be recognised in some way. Why should one take precedence over the other? Perhaps something like a 'walk of fame' might be more appropriate, that way many people's achievements can be recognised and there is no limit to the amount of people who can be added.
